Buyer additionally agrees to bear all costs for shipping, including any duties or taxes as applicable and

all risks of loss once product is picked up by shipper, as well as all titling and registration fees. No order is confirmed until the deposit is paid, meaning, cleared funds in Scorpion Motorsports, Inc.'s bank account. No order is completed until Payment in Full is made. The Buyer may be eligible for a limited warranty, provided the Buyer has complied fully with all conditions for the warranty as more fully described therein. If Buyer is not eligible for the warranty, Buyer will be solely responsible for all costs incurred due to ownership of Scorpion Motorsports product.

This order shall be construed in accordance with the laws of the State of Florida with jurisdiction being agreed to as lying in the State of Florida and venue for any action brought against Scorpion Motorsports, Inc. being brought in Miami-Dade County, Florida.

## Supplemental Terms and Conditions

- A. Deposit due is 20% of the value of the vehicle selected (From line labeled "Total" above). Signing shall hold Buyer's position in wait list with full deposit due within 48 hours. Failure to present deposit within 48 hours shall result in loss of position. Deposit is non-refundable. Delivery dates are estimates. Scorpion Motorsports vehicles are limited production, and some delays may result.
- B. Full payment is due upon Delivery. Failure to produce payment within 7 days of completion shall result in forfeit of deposit, and cancellation of order. In this event, Scorpion Motorsports shall have no further obligation to Buyer.
- C. In the event that Scorpion Motorsports, or any of its agents or dealers herein referred to as the Seller, in its sole discretion, deems that it has been furnished with any faulty, inaccurate, or false information, either verbal or written, or if any payments due from Buyer to Seller are not made as agreed, Seller may cancel the agreement in accordance with section (B) of the Supplemental Conditions above. If the vehicle has been delivered, Buyer, at Seller's option, will promptly return the above described vehicle to Seller. Buyer authorizes Seller to take whatever actions Seller deems necessary to restore possession of vehicle to Seller, including self-help, and agrees to pay Seller for all losses, costs, expenses, and damages arising out of Buyers possession of the vehicle including but not limited to reasonable attorneys fees and court costs at all levels including appeals, whenever an attorney's services are secured by Seller to enforce these conditions.
- D. It is Buyer's obligation to secure financial aid if necessary prior to issue of deposit. In the event that Buyer issues deposit and financial aid is declined, Buyer will be subject to section (B) of the Supplemental Conditions above.
- E. In the event that a vehicle is returned to Seller in accordance with section (C) of the Supplemental Conditions above, Buyer is responsible for all damages while in possession of the vehicle, including mileage accrued during the Buyer's use of the vehicle. Buyer will indemnify and hold Seller harmless from all damages and losses incurred by Seller while Buyer is in possession of the vehicle, or for the enforcement of this agreement, including reasonable attorney's fees and court costs at all levels, including appeals. Depreciation will be determined by multiplying the mileage on the returned vehicle by the amount of \$.39 per mile. Upon payment of all damages the Buyer will be released from the conditional sales agreement. Seller shall be entitled to keep deposit.
